Note concerning columns (1) and (2) / Note concernant les colonnes (1) et (2)

In accordance with Decision N° 156 taken by the enlarged Commission on 21.12.2018, as of 1 January 2019, the revised method of adjustment is applied. It consists of adjusting the national unit rate (column (1)) and subsequently to add the approved administrative unit rate (0,14 EUR for 2019).

The global unit rate of charge (sum of adjusted national unit rate and administrative unit rate in EUR) is presented in column (2).

En accord avec la Décision N° 156 prise le 21/12/2018 par la Commission élargie, à partir du 1er janvier 2019, la méthode révisée d'ajustement est appliquée.
