Title: Renewal of the fence and replacement of terrain lighting on the site of the Maastricht UAC

Technical subject matter: Detail design & engineering, procurement, supply, construction, installation, testing, commissioning and putting into operation of a new fence and terrain lighting on the site of the Maastricht UAC.
