2.1	Only original LENOVO parts are allowed
2.2	All provided configurations shall have the same parts installed.
3	In consultation with the Technical Manager the material shall delivered to EUROCONTROL MUAC, Horsterweg 11, 6199 AC Maastricht-Airport during the opening hours of the store.
4	The warranty of the equipment has to be three years, with exception of the mouse which will have one year. The tenderer shall also offer an option with 5 years warranty. EUROCONTROL will decide based on the prices whether 3 or 5 will be acquired. This will be done per deliverable.

The Technically compliant Tender with the Lowest Contract Price will be considered as the best choice for contract award and is therefore the economically most advantageous Tender, provided that no factors or risks to EUROCONTROL would justify a different recommendation (for example, failure to achieve successful contract negotiation).
