**Title:** Surveillance evaluation and specifications

**General:** EUROCONTROL\* is an intergovernmental organisation with 41 Member and 2 Comprehensive Agreement States. We are committed to building, together with our partners, a Single European Sky that will deliver the air traffic management (ATM) performance required for the twenty-first century and beyond.

**Technical subject matter:** In the context of the Surveillance System and Sensors activity, a tasking contract is required to support evaluation and specifications tasks. This will provide deliverables in the surveillance evaluation plans, execution and reports, surveillance specifications support and surveillance infrastructure modernisation support.

A call for tender is launched in order to find a contractor for a contract to be concluded for three years with 2 optional extensions.

**Main selection, assessment and award criteria:**

1	Quality of the overall documents provided to support the reply to the CFT.
2	University degree (Master level or PhD level) in Engineering or Mathematics/Physics
3	Very good knowledge of English (oral/written) and demonstrated ability to produce and to deliver presentations to international audiences in this language
4	Strong organisational, drafting and reporting skills based on previous projects
5	Experience in co-operation with stakeholders such as ANSPs, Airlines or Industry.
6	Experience in collaborative activities in international working groups.
7	Knowledge in operational, safety and performance requirements relevant to surveillance applications
