<u>Technical subject</u> matter:

As Europe's skies and major airports become increasingly congested, there is need for Air Traffic Management (ATM) technologies to evolve from ground-based infrastructures to more advanced systems based on new technologies – including European GNSS programmes like EGNOS and Galileo.

Both EUROCONTROL and the European Union Space Programmes Agency (EUSPA) have a shared objective of developing and exploiting European GNSS technology to improve accessibility, efficiency and safety to European operators, pilots and airports. EUROCONTROL activities in this field complement those of the EUSPA to ensure that the development and implementation of satellite-based navigation provides an optimal solution for European airspace users.

In this context, a fourth specific grant agreement has been concluded between EUSPA and EUROCONTROL for the period 2022-2025. Work Package 3 of that agreement focuses on supporting and providing advice on Regulatory and Standardisation aspects, with particular emphasis on the development of aviation GNSS RFI mitigation capabilities.

This tasking contract aims to validate DFMC MOPS (ED259revA) RFI detection requirements and to investigate interference events in aviation by conducting flight data collection and analysis.
