<u>Technical subject</u> matter:

The ATS Messaging Management Centre (AMC) was developed and implemented by EUROCONTROL upon a request from the ICAO European Air Navigation Planning Group (EANPG). Since 2001, AMC has been providing AFTN/CIDIN/AMHS network management service to 55 States in the EUR/NAT Regions in accordance with the ICAO Doc 021 and official letters exchanged between the Director General of EUROCONTROL and the Regional Director of the ICAO EUR/NAT office.

In November 2017, the NMB/20 gave a positive opinion to the European Commission pointing out that AMC/EDS service should be provided centrally by NM and the NF IR should be amended to include AMC/EDS

The core of the AMC service is the AMC systems run on EUROCONTROL NM Infrastructure.

The contract covers the AMC test and operational platforms will contain various interventions including:

- √ diagnosis regarding a reproducible problem.
- ✓ correction of an errors and bugs.
- estimating new functionalities or modifications of existing functionalities.
- ✓ development of new functionalities or modifications of existing functionalities.
- ✓ estimating and modification of the S/W to cope with an IT architecture.
- changes due to the evolution of the EUROCONTROL technical environment.
- ✓ validation of the S/W before migrating to the production environment.
