Title: Acquisition and delivery of Vectra AI equipment and installation services

General:

EUROCONTROL has 41 Member States and is a civil-military intergovernmental organisation committed to building, together with its partners, a Single European Sky, i.e. arrangements allowing the air navigation management system in Europe to achieve the level of performance required for the coming decades.

Technical subject matter:

The purpose of this CFT is to acquire Vectra AI hardware and software including corresponding installation services for MUAC. The contract will be awarded to the economically most advantageous tender as specified in the i-TEPO-E document.

Main selection and assessment criteria

TECHNICAL CAPACITY CRITERIA
1. Authorised Status: The Tenderer shall be a recognised partner with minimum level of Ambassador of Vectra and provide evidence of his partner status. (Ref M01 in section 3.2.1 in the Technical specifications)
2. Reference cases: The Tenderer shall provide at least two reference cases of successful installations of similar or larger size and characteristics, being Vectra AI equipment, completed within the last 18 months. Time and size of the completed installations shall be clearly indicated. (Ref M02 in section 3.2.1 in the Technical specifications)
3. Key Staff: The Tenderer shall provide evidence to employ or contract at least two staff members capable and experienced to perform the required installation and configuration activities. Evidence shall be provided by providing CVs with reference to minimum 2 similar projects. (Ref M03 in section 3.2.1 in the Technical specifications)
TECHNICAL ASSESSMENT CRITERIA
1. The Contractor shall supply all of the following Vectra AI equipment as listed in the configuration under Section 3.2.2 in the Technical Specifications document.

2. Installation services: Tenderer shall deliver maximum 4 (four) installation/configuration days to rack/stack and deliver the necessary documentation. These days shall be delivered between 1/09/2024 and 31/12/24. (as stated in Section 3.2.2 in the Technical Specifications document)
3. Delivery: All equipment shall be directly delivered to the EUROCONTROL Maastricht UAC - Horsterweg, 11 6199 AC Maastricht-Airport - The Netherlands, referred to as The Customer throughout this document. (as stated in Section 3.2.3 in the Technical Specifications document)
4. Equipment Specifics: Tenderer shall declare that all Nutanix equipment shall be new, originally manufactured and certified equipment, and delivered with minimum the standard European warranty or the warranty provided by the Manufacturer, starting at the Provisional Acceptance of said equipment. The equipment shall be registered under the name EUROCONTROL. (as stated in Section 3.2.3 in the Technical Specifications document)
5. Dimensioning and Capacities: All the dimensions and capacities of all the Nutanix equipment to be supplied shall exactly match those required in these specifications. (as stated in Section 3.2.3 in the Technical Specifications document)
6. Delivery criteria: All equipment shall be delivered 4 weeks after contract signature at MUAC premises. No equipment shall be ordered on the account of EUROCONTROL before the contract has been signed by both EUROCONTROL and the Contractor. (as stated in Section 3.2.3 in the Technical Specifications document)
