**DIRECTIVE N° 10/74**

**relating to the acceptance of the designation by the European Commission of EUROCONTROL, acting through its Performance Review Commission, supported by the Performance Review Unit, as the performance review body**

THE PERMANENT COMMISSION FOR THE SAFETY OF AIR NAVIGATION:

Having regard to the EUROCONTROL International Convention relating to Co-operation for the Safety of Air Navigation of 13 December 1960, as amended by the Protocol signed at Brussels on 12 February 1981, and in particular Articles 7.3 and 13 thereof;

Having regard to the Protocol consolidating the EUROCONTROL International Convention relating to Co-operation for the Safety of Air Navigation, which was opened for signature on 27 June 1997, and in particular Article 2.1 of the consolidated version of the Convention annexed thereto as provisionally applied under Decision N°71 of the Permanent Commission of 9 December 1997;

Having regard to the Decision N°72 of the Permanent Commission of 9 December 1997 on early implementation of certain provisions in the revised Convention, in particular on the establishment of a provisional Council;

Having regard to the Memorandum concerning a Framework for Cooperation between EUROCONTROL and the European Commission, signed at Brussels on 22 December 2003;

Having regard to the Framework Financial Agreement of 19 November 2009 between the European Union and EUROCONTROL relating to the provision of financial support to EUROCONTROL for the implementation of the Single European Sky and other Community Policies;

Considering the Single European Sky initiative developed within the European Union;

Considering that it is desirable to authorise the Agency to accept the designation by the European Commission of EUROCONTROL, acting through its Performance Review Commission, supported by the Performance Review Unit, as the performance review body;

Considering that the designation by the European Commission of EUROCONTROL as the Performance Review Body is without prejudice to the Pan-European ATM Performance Review system developed in EUROCONTROL in accordance with its constitutional framework;

Considering that the Permanent Commission has to give the final ruling on the Terms of Reference & Rules of Procedure of the Performance Review Commission while the EUROCONTROL Provisional Council has to appoint the PRC's Members and chair.

On the proposal of the Director General and the Provisional Council,

GIVES THE FOLLOWING DIRECTIVE TO THE AGENCY:

Article 1

The Agency is hereby authorised to accept, on behalf of the Organisation, the designation by the European Commission of EUROCONTROL, acting through its Performance Review Commission, supported by the Performance Review Unit, as the Performance Review Body.

Article 2

In undertaking the tasks of Performance Review Body, EUROCONTROL shall act in full compliance with its constitutional framework and in particular with the Terms of Reference and Rules of Procedure of its Performance Review Commission.
