DIRECTIVE No 14/83

regarding the development and demonstration of Centralised Services

THE PERMANENT COMMISSION FOR THE SAFETY OF AIR NAVIGATION:

Having regard to the EUROCONTROL International Convention relating to Co-operation for the Safety of Air Navigation of 13 December 1960, as amended by the Protocol signed at Brussels on 12 February 1981 and in particular Articles 6.1(b) and 7.3 thereof;

Having regard to the tasks of the Organisation under Article 2.1 of the revised Convention, reproduced in the Annex to Decision No 71 of 9 December 1997, and to the tasks entrusted to it by the Contracting Parties;

Whereas the Centralised Services are based on existing tasks of the Organisation already performed by the Agency;

Whereas the concept of Centralised Services has been the subject of extensive Stakeholder consultation;

Whereas the Centralised Services are intended to be pan-European services covering the EUROCONTROL Member States' airspace;

Whereas the Centralised Services will support the implementation of SESAR development on a central basis;

Whereas the Centralised Services will through cost reductions significantly contribute to the efficiency of the network;

Whereas the operational, technical and financial benefit of the Centralised Services will be demonstrated by the Agency in order to operate these services at a later stage;

On the proposal of the Director General and the Provisional Council,

HEREBY ISSUES THE FOLLOWING DIRECTIVE:

Article 1

The Agency shall be tasked with assessing and demonstrating the operational, technical and financial feasibility of CS 2, 3 and 9, and the development, set up and demonstration of CS 1, 4, 5, 6, 7, 8; and proceeding to implementation of each CS only after a positive decision of the PC/CN.

Article 2

The present Directive shall enter into force on the day of its signature.
